Covid-19 has posed new leadership and management challenges, as the terms of reference between employer and employee, business and society, and between entire nations and cultures, have changed. It has also unearthed a common purpose and urgency that has powered a shift in behaviours and ways of working. Progressive leaders are trying to adopt a posture based more on trust, transparency and empowerment than on authority and hierarchy.

But this requires both a new skill set and mindset – one that is based on a willingness to learn, a coaching mentality, comfort with uncertainty, the ability to experiment, to fail fast and to move on. Not many individuals in leadership roles today have necessarily been coached with these skills through their careers.

Cross-functional collaboration helps you get the best out of your teams. # Geopolitical Risks: No Longer on the Periphery

The biggest external risk to India's growth outlook is the escalation of geopolitical tensions, especially as it spreads to the Asian region. The Russia-Ukraine crisis exacerbated global divisions, which were already hardening in the wake of China's growing assertiveness and a worldwide shift towards political nationalism. As flashpoints involving China with Taiwan and India mature to a point of potential conflict, these fault lines

will only deepen. This will create burdensome challenges for businesses as regulations involving international supply chains, trade and investment, taxation, fund flows, IP and the movement of people will all become subject to geopolitical considerations as opposed to economic ones.

**Pramit Pal Chaudhuri**, Foreign Editor at the Hindustan Times, is a specialist in the field of geopolitics and its interplay with the economy. A senior journalist, he is presently a Fellow and Head of Strategic Affairs at the Ananta Aspen Centre of India and an advisor to two consultancies, the Rhodium Group and BowerGroupAsia. Pramit has been a Member of the Indian government's National Security Advisory Board for four years. He will present his views on how global power systems and Asia's security architecture are shifting in profound ways.

#### Power Play: India's Shifting Political Landscape

The electoral success of the BJP reversed a decades-old trend of weak coalitions and wafer-thin majorities where reforms were sacrificed at the altar of populism in a battle for political survival. The rise of Mr Modi promised to change all that. But the reality is rarely so simple, and deep into the BJP's second term today, India's political economy still remains something of an enigma. Many significant changes – the Aadhar-mobile-based financial

revolution, subsidy reforms, the drop in political corruption, the provision of basic amenities and the nation's revitalised military posture – have been implemented with a scale and efficiency India has never known. At the same time, some economic priorities – privatisation, fiscal reforms, tax reforms, ease of doing business – have received less attention. As one analyst put it, while the historical template of economic policy making in India has been expelled, its replacement is as yet still evolving. How is this phenomenon likely to play out in the coming years?

**Rajat Sethi**, a key contributor to the BJP's political strategy as well as economic policy positions, will provide a perspective on these issues. Rajat has degrees from the Indian Institute of Technology (Kanpur), the Massachusetts Institute of Technology and Harvard University, and spent the first ten years of his career in the corporate world. Subsequently, he joined the BJP where he played a key role in its electoral successes through the use of new-age analytical tools. Thereafter, he has been an Advisor to the Chief Ministers of Jharkhand and Manipur, and is also a Senior Research Fellow at India Foundation, an economic and policy think tank.



#### Cyber Security: It is Not About IT Alone

*Amit Dubey*, Author, Innovator, National Cyber Security Expert and Crime Investigator



Cyber crimes have dramatically evolved in nature and scope in the last few years. Recent data by the Indian Computer Emergency Response Team (CERT-IN), the government's nodal cyber security agency, shows that cyber security attacks increased by 500% since the lockdown in March 2020. The majority of data breaches are on account of human errors. However, there is a silver lining to this. If executives are educated to identify and respond to

such threats in advance, the bulk of breach incidents could be avoided. What should companies do to safeguard their systems? What must CXOs and business leaders be mindful of, at an individual level?

**Amit Dubey** is a National Security Expert and a Crime Investigator on Cyber Forensics and Ethical Hacking for various Indian investigation agencies and Police departments. A prolific speaker on TV, radio and YouTube, Amit is frequently invited by arms of the government, including defence forces, to train their cyber professionals. He is the author of two books, Hidden Files: Tales of Cyber Crime Investigation and Return of the Trojan Horse: Tales of Criminal Investigation, which include learnings from some of his more thrilling cases. Amit, through real-life examples, will provide guidance on how to improve personal security consciousness and avoid common pitfalls, and share case examples of companies that have been victims of cybercrime.
